- Bank reference addressed to RBC Royal Bank (Cayman) Limited confirming a relationship for at least 3 years
- Appraisal report/construction estimate / Purchase Agreement
- Personal Statement of Affairs. The RBC Form is attached.
- Confirmation of employment, confirming annual bonus if applicable (or Company financials, if self-employed)
- Last 2 years income tax returns
- Two (2) forms of picture identification (passport/drivers licence/voters registration)

- Valid photo identification
- Proof of permanent address (not older than 1 year)
- Proof of current occupational income (where applicable)

Self-Employed clients

The following documentation is required for processing your request:

- Two (2) of the following valid forms of photo identification: Passport, Voter's Registration Card or Driver's License. Where applicable, name changes must be evidenced by Marriage License, Affidavits, Deed Poll, etc.
- Financial Statements for the last three (3) years supported by Bank Statements
- Cash flow projection for the next twelve (12) months
