# **RBC High Interest eSavings Account Contest**

### **Full Contest Rules and Regulations**

Please read these Contest rules ("Contest Rules") in their entirety before entering the Contest. Do not enter the Contest unless you agree to these Contest Rules. Participation in the Contest constitutes unconditional agreement and acceptance of these Contest Rules which are final on all matters relating to the Contest. Sponsored by Royal Bank of Canada ("Sponsor"). By entering this Contest you agree to be bound by the decisions of Contest Sponsor which are final and binding in all respects.

- 1. CONTEST PERIOD: The Contest runs from August 12, 2013 at 9:00:01am Eastern Time ("ET") to October 31, 2013 at 5:00:00 p.m. ET (the "Contest Period").

4. PRIZES: Total value of all Prizes available to be won is \$125,000 CDN.

**GRAND PRIZE**: There is one (1) Grand Prize available to be won consisting of \$50,000 CDN which will be deposited directly into the winner's Eligible Account, if applicable, or in the case of a No Purchase Entry winner, payable by cheque.
