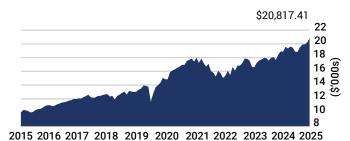

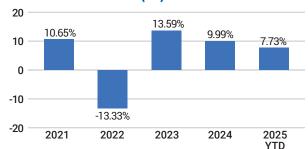

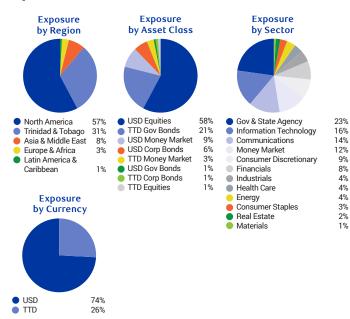
Calendar Returns (%)

Market Update

Trinidad and Tobago's Real GDP contracted by 2.1% y-o-y in the first quarter of 2025, reflecting declines in both the energy and non-energy sectors of 4.8% and 1.0%, respectively. Preliminary figures from the Ministry of Energy and Energy Industries indicate mixed outcomes in the early months of the second quarter. In April 2025, natural gas production decreased by 2.1% y-o-y, while crude oil output registered a modest increase of 0.3%. Within the petrochemical industry, production rose for ammonia (6.9%) and urea (26.7%), but methanol output fell sharply by 28.1%. Meanwhile, activity in the non-energy sector is likely to have remained subdued in the second quarter of 2025. Central Bank indicators suggest that while the distribution sector continues to perform positively, though at a slower rate, this was likely offset by weak performance in the construction and manufacturing sectors. According to data from the Central Statistical Office, the unemployment rate stood at 3.8% at the end of Q2 2025, improving from 4.9% in the previous quarter and the Q4 2024 rate of 5.5%. Headline inflation, as measured by the Consumer Price Index, rose to 1.4% (year-on-year) in August 2025 from 0.4% in August 2024. Core inflation, which excludes food prices, rose 1%. Financial conditions were generally favourable though market liquidity continued to be somewhat tight. Examining international and domestic developments and prospects, the CBTT's Monetary Policy Committee maintained the repo rate of 3.5% in September 2025, however, during the third quarter, the 1-year TTD yield increased. Short-term rates have increased due to lower excess system liquidity, driven by substantial primary market borrowing activity, which in turn has exerted upward pressure on longer-term rates. The local stock market continued to decline in the third quarter of 2025 with the TTCOMP Index falling by 4.54%; only two of the top ten listed companies registered growth on a quarter-on-quarter basis.

In contrast, the S&P 500 Index gained 7.79% over the same period driven by strong performances in ten out of the eleven sub-sectors. The Information Technology and Communications sub-sectors delivered double-digit returns of 13.0% and 11.8%, respectively. Meanwhile, the Consumer Staples sub-sector lagged, posting a return of -2.90%. At its September 16th-17th meeting the US Federal Open Market Committee (FOMC) decided to lower the target range for the federal funds rate by 25 percentage points to 4.00% to 4.25%. The Fed is still penciling in two rate cuts this year followed by one cut in 2026 and 2027. On October 1st, the US government shut down for the first time in nearly seven years, halting operations across multiple departments and agencies. The lapse of funding will force around 800,000 federal employees to stay at home on unpaid leave. The Congressional Budget Office (CBO) estimates that the total daily cost of compensation for the federal workers is roughly \$400 million. US President Donald Trump continues to pursue a highly assertive, unilateralist and transactional foreign policy that will continue to frustrate allies, adversaries and rivals. For now, tensions between the US and its top trading partners have eased somewhat, but new tariffs, which took effect in August, are the highest since before World War II. Amid evolving and challenging macroeconomic landscapes, we view any short-term equity market corrections as opportunities as we believe that equities will be supported by a slow but steady decline in policy uncertainty, tailwinds from looser fiscal and monetary policy, and continued strength in capital expenditure as artificial intelligence related spending continues.
